

# Efforts bring heat relief



#### Imagine facing day after day of triple digit temperatures without electricity, air conditioning or a fan. There are many in Hood **County in exactly that situation.**

Collaborative efforts coordinated through Mission Granbury are creating a cooling breeze for these families through **OPERATION COOL DOWN. United** Co-op and the city of Granbury have provided funds to Mission Granbury

to help people pay their electricity bill. Donations from Bond Arms and Walmart provided funds for 17 window A/C units. More than 100 fans were donated by individuals, companies and organizations, and were collected by Granbury Rehab and Nursing, Renew Home Health, Harbor Hospice and Mission Granbury. Crestwood Midstream Partners donated 50 box fans and pallets of water.

Thanks to these donors, Mission Granbury distributed 20 A/C units and 24 fans in



the first three weeks of June. This is one example of how Mission Granbury collaboratively meets needs in the community, working with donors and nearly two dozen agencies, plus community service organizations and churches.

#### "It is through these partnerships that we are able to help," said Executive **Director Dusti Scovel. "I want the** whole community to know we are in this together - and we're doing really good things, together."

# **Clothesline display supports** victims of sexual assault



Granbury may be the best small town in in 1990 in Massachusetts, and garnered the U.S., but even in Granbury people are not immune from sexual assault and abuse. In FY 2021, Mission Granbury served 40 victims of sexual assault - one male and 39 females. In Granbury in April 2022, Mission Granbury volunteers, staff and residents of the Ada Carey Shelter for Women and Children were raising awareness of Sexual Assault and of Child Abuse Prevention, two issues that are observed nationally each April.

Shelter Director Shelly Muncy had heard about the Clothesline Project, created

buy-in and support from the community and the women in the shelter to do the project in Hood County. According to theclotheslineproject.org, the catalyst for the project was the statistic that during the Vietnam war when 58,000 soldiers were killed, 51,000 women had been killed by an intimate partner.

"It was a release for them," said Shelly, who said she had a counselor at the shelter during the project to help the ladies process their feelings.

Cliff and his wife, Mary, have been married 29 years and have a 13-year-old son and a 23-year-old daughter.

# BETWEEN The Lines

There is a timeless adage, "If you want to go fast, go alone; if you want to go far, go together."

In the last two years, the human service organizations in Hood County have loudly demonstrated that we work collaboratively – not competitively. We are sister

organizations, blending our services to reach completely around our neighbors who need help. We work together, identifying and filling gaps.

We support each other by sharing fundraising events on social media, attending when we can. When we see each other's name on our caller ID, we pick up, because we know there's a need. When our emergency assistance coordinator has an overflow of fresh produce or commercial-size food items, we share with Rancho Brazos Community Center. Likewise, when we're short on snacks for our backpacks, Rancho Brazos often saves the day.

Paluxy River Children's Advocacy Center and our Family Violence Program work hand-in-hand to educate the public about preventing domestic violence, sexual assault, and child abuse and neglect. They also provide ongoing counseling services to many of the children we serve.

We often partner with Hood County Children's Charities to provide immediate emergency needs for children, such as car seats, winter coats, clothing, emergency housing or other household needs. If the situation is critical, HCCC can make a decision and implement action within a matter of hours – while we manage longer term solutions.

We strongly support, promote and sign-up families for Hood County Christmas for Children every year and have enormous respect and appreciation for all they do.

The Senior Center connects us with their clients who need to be added to our grocery delivery route or senior advocacy program, and StoneWater Church rallies volunteers to make those deliveries, a service that is growing exponentially.

One of our strongest collaborations is with the Salvation Army. Several times a week, case managers from both organizations work in tandem to keep the lights on or keep a family in their home during a time of distress. Maybe it was a cancer diagnosis, the loss of a loved one or an unexpected car repair. These days the crisis is inflation, and it's very real.

People often ask me how many non-profits there are in Hood County and I can honestly say "I don't know." But I do know this. It takes all of us to provide the services needed in this community. As our population grows and the needs in our community explode, it is imperative that we continue to work together, to identify the needs and join hands to fill them.

Staff and residents designed seven shirts which were hung on a clothesline on the Hood County Courthouse lawn. Blank T-shirts and markers were left there, with an invitation for other victims to participate, creating a T-shirt or putting a clothespin in a jar to signify that the person was or knew someone who was a victim/ survivor. At the end of the month there were 20 T-shirts hanging on the clothesline and 36 clothespins in the jar.

"It was phenomenal and heartbreaking at the same time," said Shelly. "Passersby commented that it was a very moving display, and one said 'It got my heart.""

Shelly definitely wants to continue doing the project every year. She wants victims to know they are not alone; she wants to encourage them to speak up and find help if they haven't already.

"You must talk about it and recognize that it is never your fault," said Shelly. "You can't prevent something if people are not aware of it."

As of last fall, Hood County now has a Sexual Assault Response Team; the first

Court Appointed Special Advocates



## STAFF SPOTLIGHT William "Bill" Dombrowski



If you need a laugh or an understandable answer to a question about family court, the man you need to see is Court Appointed Special Advocate Volunteer Supervisor Bill Dombrowski.

Although Bill has been in Granbury almost 40 years, his early years were spent in a small town outside of Pittsburgh, Penn. He attended high school in South Korea, and learned a few foreign languages as he traveled with his family.

But his special talent is translating legalese into English, which he learned while

working as a family law paralegal for more than 20 years. That comes in handy today, supervising 20 CASAs and 19 Child Protective Services cases, plus advocating for five foster children as a CASA himself.

Bill attained his paralegal certificate from the University of North Texas and was named the Pro Bono Coordinator of the Year by the State Bar Association of Texas in 2013 for his work at Legal Aid of Northwest Texas, where he supervised seven evening legal clinics in five counties.

"Bill is a fierce CASA advocate for his children and a dedicated supervisor for his CASA volunteers," said Justin Rossner, director of programs/CASA and family violence. "Seeing kids moved to forever homes is what I find most satisfying," said Bill, "but unfortunately we don't have as many homes as we need."

Bill is married "for the last time," to his wife Cynthia, with whom he worked at the Legal Aid clinic. Now he is blessed with four step-children and 13 grandchildren. Plus, he enjoys the unconditional love of Blaze and Duke – his two dogs.

"A fun fact about Bill is that he can make balloon animals, which is always a big hit," said Justin.

Bill is a coffee connoisseur, who is always ready to entertain. Ask him about the time he arrested a four-star general or when he was kissed by a jaguar!
